#### **Systems**

It is recommended that a Fire system designed for "Racing purposes" be used. For example, DJ Safety, Deist, Stroud, Firefox etc. NO NON-METALLIC FITTINGS TO BE USED (As are supplied with the CAMS/FIA approved SPA system, the fittings are a plastic insert) All Fire suppression systems shall be installed to manufacturers specifications.

We suggest (in the case of an above recommend system), that the fire bottles be positioned in-line with the drive shaft (front to rear), with the actuator facing rearward, and the bottle slightly inclined (5-10 degrees) upwards to the rear. This will help ensure that the siphon tube is "Buried" in the fire agent during an emergency situation, under rapid deceleration (parachute out and under brakes.)

Take the time to sit down and go through filling in your entry. It is so much easier for you and us when you do. Be warned, we will be sending back incomplete entry forms.

A Hazardous chemical register is a list of all hazardous chemicals used, handled, or stored within your pit. The Safety Data Sheet will tell you how to use and manage hazardous chemicals safely. The supplier of your chemicals should provide a Safety Data Sheet upon request. **Note**: Chemicals not classified as hazardous chemicals do not require SDSs and do not need be included in this register.

#### How can you tell if a chemical is classed as hazardous?

Section 2 of the SDS will tell you if, and how the chemical is hazardous. Other indications are:

- The manufacturer or supplier provided a copy of the SDS with the chemical
- . The label of the product includes:
  - o diamond-shaped warning pictograms (see right)
  - o signal words Danger or Warning
  - hazard or precautionary statements such as Toxic if swallowed and Wear eye protection
  - o risk or safety phrases such as Harmful if swallowed and Keep out of the reach of children.

Contact the manufacturer or supplier for more details or for a copy of the SDS. Many companies also provide SDSs online.
